b. Submission of relevant documents viz., registration certificate, the live registration order of the class concerned with upto date renewal for the year 2025-26 with valid Digital Signature Certificate, return for filing **Latest I.T.Certificate and GST registered number** and on production of proof of having similar experience, including date of completion of work, actual value of work done etc., should be submitted in online.

c. EMD payment shall be paid through on-line in the portal (<https://tntenders.gov.in>) or through **eBG** (as per the list of banks attached in (Annexure –II) itself. Bidder should not make any payment to SIPCOT through DD/NEFT/RTGS.

ii. **Single cover system shall be adopted for the above work.** The tender document shall be filled with relevant details duly signed and the completed tender document along with required certificates should be submitted through online.

a. The tender will be opened by the Special Chief Engineer on the date and time stipulated above. If the last date of receipt of tender happens to be a Public Holiday, the tenders will be received and opened at the above said time on the next working day. The tenderers who are desirous of making field visits may do so at their own cost.

- b. The tender document received through “online” only shall be opened on **14.10.2025 at 15.30 Hrs** (as per server system clock) in the office of the Special Chief Engineer, SIPCOT, Chennai.
- c. Addendum/Corrigendum if any, it will be available only in the above website.
- d. The contractor should upload the documents for own possession of sufficient plants & machineries along with the obtained certificates from the Assistant Engineer, Industrial Housing Project Vallam Vadagal as specified in the tender documents for working condition of plants & machineries and proof of ownership and upload the same.
